In such case, CCAC may select the Winner from all eligible entries received prior to and/or after

(if appropriate) the action taken by CCAC. CCAC reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions.
